

[How to use]

Fujiyama Power-line Trail (hereinafter referred to as the "Field") is subject to the following items, and only those users (including the parent of users under 18 years of age, if any) who have confirmed and pledged to the "Rule of field utilization" and the contents of the "Field utilization pledge" in advance can apply.

*The pledge on the " Field utilization pledge " will be accepted by all users, including the representative of the applicant (rider) and the accompanying person(s) (including the parent of the applicant if the applicant is under 18 years of age), when the "Field utilization pledge "is made. Therefore, the representative of the applicant (rider) must fully explain the rules of field use and the contents of the Field utilization pledge to the accompanying persons (including the parent of users under 18 years of age, if any) and obtain their pledge before applying for use.

*If you are a beginner with less than one year of experience on MTB or off-road e-bikes, we recommend that you ride with an intermediate or advanced rider or guide.

*The use of this field is at your own risk. It is recommended that users purchase accident insurance, such as sports safety insurance, in case of an emergency.

1. Sign up for use

No single user is allowed to use the trail. The representative of the applicant (rider) must fill in the following information in the application e-mail address: name of the representative, name of the accompanying person, date of the ride, start time of the ride, address of each person, age, contact information such as cell phone, and years of MTB experience.

*If child under 18 years old is included, please write the name of the parent next to the name of the child under 18 years old.

2, Deadline for application

3 days before the field reservation

3. Available days

All year round

*If there are too many people using the field, or if the field is under maintenance, the field cannot be used. Please check the website for available days and number of users.

*The use of the field may be cancelled due to bad weather such as typhoons or sudden accidents.

4, Usage time

Period of use: Apr. to Sep.

Usage time: 9:00 a.m. - 5:00 p.m.

Last start time (approx.): 3:00 p.m.

Period of use: Oct. - Mar.

Usage time: 9:00 a.m. - 4:00 p.m.

Last start time (approx.): 2:00 p.m.

*It takes about 1 or 2 hours to complete a lap, so please check the time of sunset and start your ride so that you will not be riding after sunset.

5. Usage fee (1 day)

Adults: 4,000 yen

Kids: 2,000 yen (under 18 years old)

6. Payment of usage fee

The fee must be transferred to the designated bank account by the day before the day of use. Please note that bank transfer fees are the responsibility of the applicant.

Payment in cash is not accepted. Please follow the instructions of the facility to be used and pay the facility usage fees separately.

7. Change of Use Date and Cancellation

If you wish to change the date of use, please contact us at least one day before the date of use. If you wish to cancel the use, please contact us immediately.

*Please confirm the section about Refund of usage fee due to change or cancellation of usage

8. Refund of usage fee due to change or cancellation of usage

In the event that a refund of the usage fee is required after payment of the field usage fee due to a change in the usage date or cancellation of the usage for reasons beyond the Company's control (including rain, etc.), the refund will be made as follows. However, if the usage date is changed at least one day prior to the usage date, the usage fee will not be refunded and the usage date will be changed.

In the event that the Company cancels the field use for its own reasons, the full amount of the field use fee will be refunded. The refund will be transferred to the user's designated bank account by the end of the month following the month in which the reason for the refund occurs.

*Please contact the facility regarding refunds and cancellation fees for facility usage fees except for the field usage fees.

9. Conditions of Use

①Those who can pledge to the "How to Use /Rule of field utilization /Field utilization pledge at the time of application for use.

②Those who can observe the rules and manners and follow our instructions.

③Those who will comply with the rules and manners and follow our instructions.

*The pledge on the " Field utilization pledge " will be accepted by all users, including the representative of the applicant (rider) and the accompanying person (including the parent of the applicant if the applicant is under 18 years of age), when the " Field utilization pledge " is made. Therefore, the representative of the applicant (rider) must fully explain the rules of field use and the contents of the Field utilization pledge to the accompanying persons (including the parent of users under 18 years of age, if any) and obtain their pledge before applying for use.

10. Equipment restrictions

①Bicycles other than MTB and off-road e-bikes are not allowed.

②Bicycles without pedals, front and rear brakes are not allowed.

11. Riding by persons other than those who have applied for use is prohibited.

"Bicycles may not be ridden by anyone other than the user (including the accompanying member) who has applied for use in accordance with [1.Sign up for use]. Please note that you may be asked to show your registration number to confirm your use.

12. User Restrictions

In the event of any of the following cases occurring, the application and use of the field will be refused.

①When the person who intends to use the field is under 18 years old and is not accompanied by a parent (who is obliged to monitor the person) or when it is recognized that the parent does not know about the application for use.

②When it is recognized that a rider is riding alone.

③When it is recognized that the purpose of field use is other than bicycle riding.

④When it is recognized that a rider has a risk of harm to public order or good morals.

⑤When it is recognized that a rider intends to use the field or his/her representative is a member of a crime syndicate, a person related to a crime syndicate, a member of a general assembly, a person involved in a social movement, or any other person equivalent thereto (hereinafter referred to as "antisocial forces").

⑥When it is recognized that antisocial forces are involved in the event, etc. organized by the person who intends to use the field as an exhibitor, co-organizer, co-sponsor, sponsor, or entrusted with business.

⑦When it is recognized that there is a possibility of inconvenience to other users of the field.

⑧When it is recognized that there is a possibility of damaging the field or electric power equipment.

⑨When it is recognized that there is an obstacle in the management and operation of the facility.

⑩In addition to those listed in the preceding items, when the Company deems the use of the facilities inappropriate.
